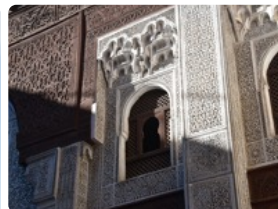

**January 19 - Sunday****Discovering Fes**

Get lost in the largest old town in the world in the medina of Fes, whose meandering narrow stone pathway and blue tiles have been a UNESCO World Heritage site since 1981. Step within its elaborate gates and into specialized sections known as souks, including wood, ceramic, metal, and leather.

At the center of the medina, you'll find the Qarawiyyin Mosque and University, as well as 14th-century schools, a museum of woodcut art, and more.

It's best to follow a guide through the maze to make sure you can learn about all the history surrounding you without surprise meet-ups with fully-laden carts, scooters or donkeys! The medina is more Arab in origins, and strategically sits on a hill.

Next, we will pay a visit to a tannery and dye works, where leather and hides are still tanned and naturally dyed using medieval methods. If you are interested in purchasing leather in Morocco, this is your stop.

Food in Fes is fantastic and we will have opportunities for guided-suggested meals for both lunch and dinner.

January 20 - Monday



Merzouga

Start your day bright and early and travel south toward Merzouga. Prepare for a long driving day with plenty of stops to enjoy the ever-changing Moroccan landscapes from the agriculture plains of Fes to the forests of cedar, pine and oak of the Middle Atlas mountains.

Enjoy sightings of the local Barbary macaque monkeys before stopping for lunch in Midelt (the apple city), Continue over the Tizi Talremt pass 1900mtr (6233 ft) and into the Ziz Valley, known for its hidden oases and palm tree clusters. Along the road, you will see many fortified houses known as ksars—built to protect precious wares, including gold, salt, and spices.

Continue to Erg Chebbi, an extensive sea of sand dunes covering an area of 13.5 square miles (35 square km). Never stationary, the massive dunes shift and travel depending on the changing wind!

Today we will enjoy a 4x4 excursion in the desert and have lunch at the house of Gnawa Group and enjoy their music. Dancing anyone?

After we return to the hotel, in the afternoon we will meet our sherpas, ascend our camels, and take a breathtaking 90 minute camel ride to watch the sunset. The camels will then take us to our desert camp for a delicious dinner and overnight in the camp!

BOUMALEN DADES

In the morning, we will start the day with a truly unforgettable experience riding the camel across the desert during sunrise, watching the landscape turn from darkness to remarkable shades of orange and red. After breakfast we will drive to Erfoud, known for its dates festival and fossil mining. Here we will visit a local collective to learn more about the excavation of these breathtaking fossils, and meet local artisans engaged in creating both beautiful and practical art pieces.

Driving south of the Atlas Mountains, the desert Dades Valley is home to some of the most beautiful landscapes in Morocco. The river winds through a plateau full of almonds, figs, apricots, and peach trees, and the oases dotted through the valley have been spots for Berber kasbahs for centuries (also giving it its nickname of the Route des 1000 Kasbahs).

We will continue our drive to Todra Gorges, a massive trench that rises over 250 meters to form one of the most dramatic and spectacular national sights in Morocco. We will continue on to Boumalen Dades and stay at Hotel Xaluca Boumalen for the night.

January 23 - Thursday



AIT BEN HADDOU

Depart the Dades Valley and drive along the road of Thousand Kasbahs. We will head west to Kela'a M'gouna. Known for its Festival of Roses, here we will see extensively cultivated farmland bordered with fragrant rose bushes.

We will continue our travel to Ait ben Haddou - a hilltop site almost unchanged since the 11th century. It's Kasbah is one of the most beautiful in Morocco and the fortified village is a fine example of clay architecture. You may recognize the site from films and TV shows, such as Lawrence of Arabia, Game of Thrones, Gladiator and many others.

Explore the old town, heading up to the top of the hill for some scenic views. Afterward, we will visit Tawsna - a riverside teahouse - for a tasty lunch including freshly made Amazigh bread, lentil soup, Moroccan sweets and mint tea. This establishment provides women with income to support themselves and their children. They use natural ingredients sourced from local cooperatives to prepare tea and pastries, taking great pride in sharing their stories and giving visitors an authentic Amazigh experience. After lunch, we will go for a visit to a women's cooperative for traditional Berber rugs.

DESTINATION MARRAKECH

This morning, we will ascend the High Atlas mountain range (by van, not on foot!) and look out for the highest peak, Mount Toubkal (13,671 feet). Driving through the High Atlas Mountains we will stop near the top of the Tizi n'Tichka pass (7,415 feet) to enjoy the view over the mountain range.

Next stop, Marrakech! We will go for a walking visit with an expert local guide. The colorful oasis city of Marrakech offers an ancient and colorful tangle of bazaars alongside Moorish Riads and palm trees. We will make our way (guided, of course) through the alleys of the medina, where carpets, ceramics, parchment lamps, and huge spice stalls in all colors are stored up to the roof in the alleyways characterized by stairs and vaults.

We will also visit Djemaa el Fna, Bahia Palace, and Koutoubia Mosque.

Later in the evening, we will visit the outdoor marketplace of Marrakech, where you will find food stalls alongside snake charmers, trained monkeys, artists and musicians.

This morning, we will drive a short hour to a farm in the countryside of Marrakech where we will enjoy a cooking class by a modern Moroccan chef. He will teach us the art of seasoning with Moroccan herbs and spices. We will cook Tajines and salads, and after a splendid feast of our own making, we head back to Marrakech.

We will enjoy an (optional) visit to the Majorelle Botanical Gardens, boasting about 3000 species of plants, an art deco villa, and Berber Museum, which highlights the history of Morocco's indigenous inhabitants. One of the most visited places in Morocco, it was designed by the French artist, Jacques Majorelle in 1924, and was purchased by Yves St Laurent in 1980.

In the afternoon, you can explore Marrakech at leisure with plenty of suggestions for delicious nearby restaurants.

DESTINATION ESSAOUIRA

After exploring Morocco's mountains, desert, and bustling marketplaces, we drive toward the coast for two nights in beautiful Essaouira. The city has been a UNESCO World Heritage Site since 2001, with Andalusian- and Portuguese-influenced blue and white painted houses, surfing, and art all contributing to the popularity of the white city on the Atlantic.

Though the city was built in the mid-1700s, it became a favorite of the hippie movement in 1967, drawing dropouts, artists, and tourists to its shore; the spirit lives on when the bohemian crowd flocks to the city every summer for the Gnaoua and World Music Festival.

The wide, bright alleys of the medina are home to traditional souks, city gates, art galleries, and locally created crafts, leading to the central Mulay El-Hassan Square and its restaurants and hotels. Meanwhile, fishermen pull up to the port where fishing boats are made by hand, nets are mended and fishing lines are baited.

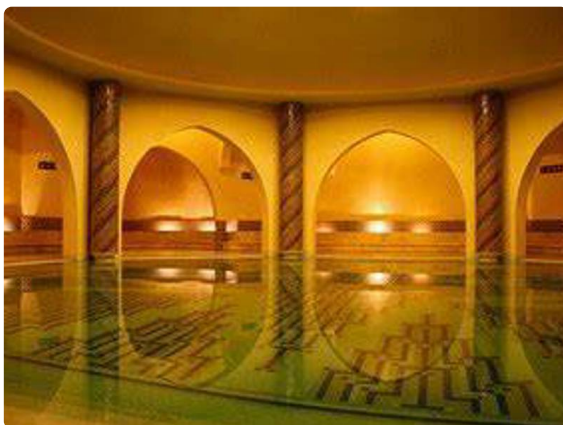

Trip Costs and Discounts

Cost of Trip

\$4,299 per person, plus air and travel insurance

A deposit of \$450 holds your space on the trip. Final payments must be completed by September 1, 2024.

Travel insurance will be available at \$375, payable within 15 days of initial deposit. While travel insurance is not mandatory, it is strongly recommended. If travel insurance is declined, Wide Horizons Travel will provide an insurance waiver which must be signed by each traveler.

Group air rates from JFK to Casablanca will be available after February 1. Wide Horizons Travel can assist with transportation to JFK if needed. If traveling separately from the group, Wide Horizons Travel will provide window for arrival in Casablanca, in order for all travelers to meet our transportation from the Casablanca airport to our next stops. **There is no hotel stay in Casablanca upon arrival.**

A discount of \$250 pp is available if payment is made in full by March 1, 2024.

In order to save on credit card fees, an additional discount of \$125 pp is available if payments are made by check.

You'll use these words most:

Greetings (Peace be with you): **Salam aleikum** (SaLAAM aLAY-kum)

Response to greeting: **Aleikum as-salam** (above in reverse)

Thank you: **Shukrun** (SHOOK - run)

God Willing (may it be so): **IN-sha Allah** (often in response to "see you soon")

Let's Go!: **Yella, Yella!**

Cheers/Bon Appetit: **Besseha** (Bay-sa-HAH)

Moroccan coffee: *Nus-nus (Noos-Noos) Half strong coffee, half cream in very small cup*



About Coffee

Morocco doesn't have the coffee culture that a lot of Middle Eastern countries do. Tea is the de facto [Moroccan drink](#). Coffee is almost never a breakfast drink though it's common to see men drinking espresso beginning mid-morning. Here drinking coffee means pulling up a chair in a cafe and sitting for awhile.

You'd never see a Moroccan standing at a bar and drinking coffee, nor would you see them walking with a cup of coffee in their hand. When Starbucks opened in Marrakech I was beyond excited that I could get a giant cup of coffee (by giant I mean over 6oz) and that I could take my giant cup to go.

There are two basic types of coffee that you can order in cafes. It's either *cafe noir* or *nous nous*. Cafe noir is essentially a small cup of espresso. It's most typically ordered by men who want a coffee. *Nous nous* translates to half and half. It's half milk and half espresso and most typically ordered by women. I have no idea why this is but it's totally possible to order either one no matter what your gender.

Moroccan coffee shop culture is a male realm. Visitors often comment on seeing shops around the country full of men sitting and chatting while enjoying a coffee or tea. This doesn't mean women don't have their own rituals – they do. You just won't see them unless you go to someone's house.

Culture dictates that women shouldn't be out sitting in cafes, though this is changing with younger generations. Don't think that women miss out, it's quite the contrary. Women do gather and often look forward to an invitation to a friend's home for "coffee time." This typically happens in the late afternoons, sometime between 5 and 7pm.

Cancellation fees will be charged to the credit card or other payment method you authorized to pay for travel services or deducted from the Supplier's refund.

1. TRAVEL DOCUMENTS, INCLUDING TSA AND DHS ACCEPTABLE IDENTIFICATION REQUIREMENTS

It is the responsibility of each Client to obtain and carry a valid passport, visa(s), and all other documents required by applicable government regulations. When traveling domestically or internationally, the U.S. Transportation Security Administration (TSA) and U.S. Department of Homeland Security (DHS) advise that everyone carry acceptable identification in order to board a flight. Acceptable identification can be found at <http://www.tsa.gov/traveler-information/acceptable-ids>; examples are DHS-designated enhanced driver's license, Passport, a foreign government passport. The name, date of birth and gender that appears on the identification card must exactly match the same such data that is listed on airline ticket(s) and booking records. You acknowledge any failure to strictly comply with these requirements may result in denied boarding or an undue delay at an airport security checkpoint causing Client to miss flight(s), and subsequent scheduled travel bookings on cruises and tours.

WHEN YOU RECEIVE ANY AND ALL TRAVEL DOCUMENTS, IT IS YOUR RESPONSIBILITY TO REVIEW AND VERIFY ALL INFORMATION FOR ACCURACY. CONTACT WHT IMMEDIATELY IF CHANGES OR CORRECTIONS ARE REQUIRED.

WHT strongly recommends that you take into account that certain countries will not admit a passenger if their passport expires within six (6) months of the anticipated date of return. Non-United States citizens may require additional documentation. Client is responsible to make WHT aware when traveling on a passport from a country other than the United States of America. WHT neither controls nor warrants the issuance of visas or approval of visa waivers related to your travel. Should a visa not be issued, WHT is not responsible for lost payments made toward the contemplated trip. Please note that rules of each country regarding entry and exit change on a daily basis.

Children and infants also require travel documents. Minors traveling with one parent, and/or without both parents, may be stopped and not admitted, unless authenticated and verified consent forms are provided to the authorities; please see <https://help.cbp.gov/s/article/Article-3643> for additional information.

1. INDIVIDUAL ENTRY AND EXIT REQUIREMENTS

Each country holds different views of past criminal offenses, whether within or outside of their boundaries. If you have a current or prior criminal offense, contact that country directly for entry and exit requirements. You can visit the US State Department Website for further information about these requirements. See, <https://travel.state.gov/content/travel.html>. We do not inquire about an individual's criminal record in the interest of respecting our Clients' privacy. 1. HAZARDOUS MATERIALS

Federal law prohibits passengers from bringing hazardous materials on the aircraft.

(1) Federal law forbids the carriage of hazardous materials aboard aircraft in the passenger's luggage or on the passenger's person. A violation can result in five years' imprisonment and penalties of \$250,000 or more (49 U.S.C. 5124). Hazardous materials include explosives, compressed gases, flammable liquids and solids, oxidizers, poisons, corrosives and radio- active materials. Examples: Paints, lighter fluid, fireworks, tear gases, oxygen bottles, and radiopharmaceuticals.

(2) There are special exceptions for small quantities (up to 70 ounces total) of medicinal and toilet articles carried in the passenger's luggage and certain smoking materials carried on the passenger's person. 1. INSECTICIDE NOTICE

We recommend that you refer to the DOT list of airports in countries that require airlines to treat the passenger cabin with insecticides prior to the flight or while on the aircraft. 1. HEALTH/IMMUNIZATIONS

You must have the proper immunizations and health screenings and required documentation of such immunizations and screenings before travel. WHT shall not assume responsibility for the accuracy of health, vaccination, or documentation prior to departure or upon landing at the final destination. In some cases, required inoculations must be recorded by Client's health practitioner on a valid vaccination certificate, which the Client must carry for proof of inoculation. If you are concerned about taking any medications or receiving certain inoculations, check with your health practitioner BEFORE booking. 1. AIR TRAVEL, SCHEDULE RECONFIRMATION, CHECK-IN

WHT shall not assume any responsibility for any air schedule changes. In rare instances, upon departure from a country, certain departure taxes must be paid in cash only, and may vary in price. Failure to use a reservation may result in automatic cancellation of all continuing and return flights, as well as forfeiture of airfares.

Airline e-tickets expire a year from issue date unless carrier fare rules in passenger's itinerary fare provide otherwise.

Due to enhanced security, it is strongly recommended that you check in a minimum of 2 hours prior to scheduled departure for domestic flights and 3 hours prior to scheduled departure time for international flights. Reconfirm flight times at least 24 hours prior to scheduled departure time for domestic flights, and 72 hours prior for international flights.

1. RIGHT TO CORRECT ERRORS/OFFERS SUBJECT TO AVAILABILITY

We reserve the right to correct errors. In the event of any pricing error or omission, we reserve the right to adjust such pricing or make any other corrections. All offers, incentives and Supplier promotions are subject to availability and may change without notice. Prospective Clients are advised to reserve early to avoid disappointment, increases in fares and additional late booking fees.

1. UNUSED ARRANGEMENTS, MINIMUM PASSENGER REQUIREMENTS AND ALTERATIONS TO BOOKINGS

When tour, cruise or package prices are based on Suppliers' contract rates, you will not be entitled to any refund for any unused portion of travel.

Some group tours are based on minimum numbers of passengers traveling; if the number of passengers falls below the minimum required, a surcharge may be imposed, or the tour may be canceled. Any cancellations of a tour or package for reason of failing to meet the minimum traveler requirement will be governed by the tour operator's cancellation policy.

If you decide to change any portion of your confirmed arrangements prior to departure or during your trip, we will attempt to assist you. Certain bookings may not be able to be changed. All requests for changes to a booking must be made in writing to WHT.

The Supplier may determine that alterations in itinerary are necessary for any number of reasons, including but not limited to severe weather. Any alterations to an itinerary are at the sole discretion of the Supplier, and WHT bears no responsibility for any changes.

1. LIMITATIONS OF RESPONSIBILITY AND DISCLOSURE

WHT acts solely as a booking agent for disclosed principal Suppliers and is not the source or provider of any travel service. Each Supplier is an independent entity with its own management and is not subject to the control of WHT. The Suppliers whose names appear in travel documentation are those actually responsible for providing the travel services purchased, and you consent to the use of those Suppliers.

BECAUSE WHT ACTS AS AGENT FOR DISCLOSED PRINCIPAL SUPPLIERS AND DOES NOT HAVE THE RIGHT TO CONTROL THE OPERATIONS OF SUCH INDEPENDENT OPERATORS AND SUPPLIERS, YOU AGREE THAT WHT IS NOT LIABLE FOR ANY PERSONAL INJURY OR PROPERTY DAMAGE, WHICH MAY ARISE OUT OF THESE SERVICES. WHT HEREBY DISCLAIMS ANY LIABILITY WHETHER BASED ON CONTRACT, TORT, STRICT LIABILITY, OR OTHERWISE, INCLUDING WITHOUT LIMITATION LIABILITY FOR ANY DIRECT, PUNITIVE, SPECIAL CONSEQUENTIAL, INCIDENTAL OR INDIRECT DAMAGES IN CONNECTION WITH THE GOODS OR SERVICES PROVIDED BY ANY PRINCIPAL SUPPLIER BOOKING THROUGH WHT, INCLUDING WITHOUT LIMITATION LIABILITY FOR ANY ACT, ERROR, OMISSION, INJURY, LOSS, ACCIDENT, DELAY OR IRREGULARITY WHICH MAY BE INCURRED THROUGH THE FAULT, NEGLIGENCE, WILLFUL ACTS, OMISSIONS OR OTHERWISE OF SUCH SUPPLIER, OR OF ANY SUPPLIER OR THEIR RESPECTIVE EMPLOYEES, AGENTS, SERVANTS, OR REPRESENTATIVES, INCLUDING, WITHOUT LIMITATION, THEIR FAILURE TO DELIVER OR THEIR PARTIAL OR INADEQUATE DELIVERY OF SERVICES, THEIR CANCELLATION AND REFUND POLICIES, FUEL INCREASES, BANKRUPTCY, OR CESSATION OF OPERATIONS AND OTHER MATTERS OUTSIDE OF WHT'S CONTROL, AND YOU HEREBY EXONERATE WHT FROM ANY LIABILITY WITH RESPECT TO THE SAME.

WHT will not be in breach of these terms and conditions or otherwise be liable to you, for any failure or delay in performing an obligation under this Agreement that is due to any of the following causes, to the extent beyond its reasonable control: acts of God, accident, riots, war, terrorist act, epidemic, pandemic, quarantine, civil commotion, breakdown of communication facilities, including web host and internet service provider, breakdown or malfunction of equipment, destruction of or serious damage to facilities, natural catastrophes including, but not limited to extreme weather events, floods and volcanic eruptions, governmental acts or omissions, changes in laws or regulations, national strikes, fire, explosion, generalized lack of availability of raw materials or energy, and any other unforeseen circumstance which is beyond the control of WHT. THE PURCHASE OF TRAVEL INSURANCE IS HIGHLY RECOMMENDED ON ALL TRIPS.

In addition, each of WHT's Suppliers have terms and conditions which include Force Majeure provisions. In the event that a Force Majeure event occurs, those Suppliers may be entitled to, and may in their sole and absolute discretion, vary, postpone or cancel any itinerary or arrangement in relation to the trip. Payment of any refund to you as a result of the non-performance of any obligations hereunder shall remain in the sole and absolute discretion of the Supplier, pursuant to their policies, although WHT shall use its reasonable efforts to secure reimbursement for you where possible.

1. CLIENT CONDUCT

Each participant in any trip escorted by WHT is expected to act responsibly and adhere to all behavior guidelines established by WHT and our Suppliers. WHT and all local Suppliers reserve the right to remove you from any facility, hotel or resort property, tour location or means of transportation if your health or your conduct appears to endanger yourself or others, disrupts the general well-being of other clients on any element of your trip, or interferes with the operation or security of the places we visit. In any such case, there will be no refund.

When you book with WHT, you accept responsibility for any damage or loss caused by you. Full payment for any such damage or loss (reasonably estimated if not precisely known) must be paid directly at the time to the accommodation owner or manager or other Supplier. You must indemnify us for the full amount of any claim (also including legal costs) made against us. We are not responsible for any costs incurred concerning a guest removed from a trip, or any portion of a trip. You agree not to hold WHT or any of its related entities liable for any actions taken under these terms and conditions. Baggage and personal effects are at all times the sole responsibility of the participant.

1. CURRENCY FLUCTUATIONS

Currency exchange rates fluctuate. Prices are subject to change based upon currency exchange rate fluctuations. WHT is not responsible for surcharges or foreign transaction fees imposed by Client's credit card or bank.

1. TRAVEL INSURANCE

WHT OFFERS ACCESS TO TRAVEL INSURANCE TO PROTECT PASSENGERS AND THEIR INVESTMENT IN TRAVEL. UNLESS SPECIFICALLY NOTED, TRAVEL INSURANCE IS NOT INCLUDED IN THE COST OF CLIENT'S ITINERARY TO PROTECT AGAINST THIRD PARTY SUPPLIER DEFAULT/BANKRUPTCY PROTECTION, DELAY, INTERRUPTION, MISSED CONNECTION FOR CRUISES, CANCELLATION, MEDICAL EMERGENCY TRANSPORTATION/EVACUATION & REPATRIATION, BAGGAGE & PERSONAL EFFECTS/LOST LUGGAGE & BAGGAGE DELAY, ILLNESS, JOB LOSS PROTECTION AND CHANGE OF PLANS, ACCIDENTAL DEATH AND DISABILITY, TRAVEL ACCIDENT/SICKNESS MEDICAL EXPENSES, AND MORE. The laws of the State of New York govern these Terms and Conditions. You hereby consent to the exclusive jurisdiction and venue of courts in Suffolk County, New York in all disputes arising out of or relating to travel bookings with WHT.

If any part of these Terms and Conditions is determined to be invalid or unenforceable pursuant to applicable law including, but not limited to, the warranty disclaimers and liability limitations set forth above, then the invalid or unenforceable provision will be deemed superseded by a valid, enforceable provision that most closely matches the intent of the original provision and agreement shall continue in effect.

These Terms and Conditions (and any other terms and conditions referenced herein) constitute the entire agreement between the Client and WHT with respect to travel bookings made with WHT by any means, and it supersedes all prior or contemporaneous communications and proposals, whether electronic, oral, or written, between Client and WHT with respect to communications with WHT. A printed version of this agreement and of any notice given in electronic form shall be admissible in judicial or administrative proceedings based upon or relating to these Terms and Conditions to the same extent and subject to the same conditions as other business documents and records originally generated and maintained in printed form.
